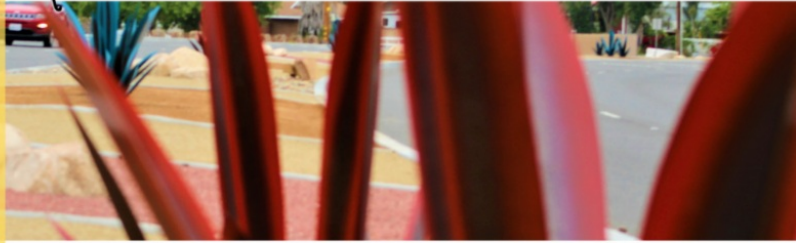

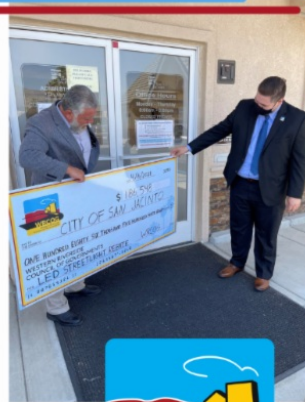

A win for San Jacinto

In 2018, the City of San Jacinto partnered with WRCOG in the Regional Streetlight Program. The program was designed to facilitate the sale of over 50,000 utility-owned streetlights to San Jacinto and 10 other local governments in Western Riverside County. Participation facilitated the LED conversion of 1,945 streetlights and takes over maintenance services. The streetlight program is an extensive energy efficiency program, that will generate savings and reduce annual energy use. In addition to cost savings and reducing energy consumption, WRCOG secured and will disburse over \$3.6 million dollars in utility rebates to the participating agencies. San Jacinto received a reimbursement of \$186,548 in April.

CODE CORNER

Illegal dumping is a problem in many communities. Illegal dumping is the dumping of any waste, such as oil, furniture, appliances, trash, litter or landscaping cuttings, etc., upon any public right-of-way, City property, or private property, without consent of the owner.

San Jacinto's Code Enforcement Division patrols the City proactively addressing illegal dumping that occurs within city limits, however, the community's help is needed. Community help is essential to catching and deterring illegal dumping. The City encourages anyone who encounters illegal dumping that has already taken place to report it to the City's Public Utilities Department at 951-654-4041. If you are witnessing illegal dumping in progress, please contact the San Jacinto Police Department by calling the non-emergency line at 951-654-2702.

Do you have items that you need to dispose of? The City's trash hauler provider, CR&R, provides San Jacinto customers with 4 bulky item pickups a year. Ramona Expressway Median Art project

The Ramona Expressway Median Art Project phase I is almost complete! Residents can enjoy the scenic art in the median as they drive through Ramona Expressway from State Street to Lyon Avenue. The agave art pieces have been installed, and solar uplighting will soon be installed. The second phase will upgrade the median segment between Lyon Avenue and Sanderson Avenue. The median was recently featured on a Channel 7 segment, praising the creativity to use art, and reduce the cost of long-term annual maintenance and water.
