Item 3.A.9 – Outdoor Dining City Council – July 7, 2020

Background

- July 1, 2020 Governor Newsom and the California Department of Public Health issued a new order to curb the spread of COVID-19
- Required Closure of all indoor dine-in restaurants in Riverside County.
- Anticipated to be in place for at least 3 weeks.



Background

- In response to Governor's Order, the City Manager, acting as Emergency Services Director issued an Executive Order establishing Special Temporary Outdoor Dining Guidelines and Procedures.
- The Order was effective immediately and takes precedence over any inconsistent provisions of the Municipal Code, Development Code, use Permit or other regulations.



Background

- The Order authorizes existing restaurants to remain operational by utilizing existing outdoor space for outdoor dining.
- Could be within existing parking lots or sidewalks.



Processes

Exempt (Most)	Review Required (Some)	Permit Required (Few)
Up to 30% Required Parking for Multi-Tenant Complex	Tent or shade structure over 10' x 10'	Within Public Rights-of-Way (Sidewalks) – Encroachment Permit
Up to 50% Required Parking for Single-Tenant Development		Withing Public Rights-of-Way (Road Closures) – Special Event Permit
No requirement to replace displaced parking.		Tent or Shade Structures requiring Building or Fire Permits
Limited Duration	Limited Duration	Limited Duration (may continue through Special Event Permit)



Requirements

- Shall not interfere with ADA Parking or Access
- Shall not interfere with Building or Emergency Access
- Shall comply with county and state social distancing requirements
- Minimum 5 foot clearance for sidewalks
- Shall comply with all County Health Department, Fire Department and Building & Safety Requirements.



Tents

- Maximum size 10' x 10' May go larger with administrative review. May require permits.
- Must be secured in place.
- No heaters shall be permitted under tents or within 2 feet of the structure.



Alcoholic Beverages

- Restaurants and food establishments licensed by the State of California will be permitted to sell and allow on premise consumption of alcoholic beverages within expanded dining areas.
- Establishments shall provide a physical barrier that meets the requirements of the Alcoholic Beverage Control Board.
- Outdoor dining shall comply with the following closing times:
 - Thursday through Saturday close at 11:00 PM
 - Sunday through Wednesday close at 10:00 PM






