DEVELOPMENT SERVICES FEE SCHEDULE

This document will assist you in calculating an estimate of Building and Engineering Permit and Plan Check and Planning Entitlement Fees for your proposed construction project. Please keep in mind that this is an estimate of **City fees only** and that there may be additional development fees from other agencies, departments, or divisions. Furthermore, there may be additional development fees from outside agencies, such as the County Health Department, your local School District, or other federal, state, or local agencies.

BUILDING DATA:

Building Permit Valuations are updated annually, effective July 1, based on the previous year's February published ICC Valuation Tables. The Building Permit Valuation is not intended to represent the actual cost of constructing a given project; however, it does provide the baseline metric for determining permit and plan check fees. Multiply the total square footage of the building by the "Per Square Foot Value" listed in the most current February ICC posting. This value will represent the total cost of construction for the purpose of calculating Plan Check and Building Permit Fees.

DECK OR PATIO, ELECTRICAL, PLUMBING & MECHANICAL FEE SCHEDULES

For new buildings or additions, these fees only apply if the builder desires to pull separate Plumbing, Mechanical, and/or Electrical Permits; otherwise, these fees are included in the combination building permit.

The following fees are intended to be applied to projects where a Per Square Foot Fee Calculation Method is not applicable due to the minor nature of work performed. For most building projects, the per square foot calculation method is to be used to determine the Electrical, Plumbing and Mechanical fees.

PLANNING AND ENTITLEMENT FEES

Application fees are typically non-refundable. Unused portions of deposits will be reimbursed upon the project's completion. The Planning Staff retains the authority to adjust the deposit amount, either higher or lower, depending on the project's complexity. The application fee encompasses a 5% Technology Fee. In addition the initial deposit encompasses a 15% Administrative Fee. Additional deposits might be necessary, and any surplus deposits will be returned upon the project's conclusion.
